

Lyons Public Library Board of Trustees

November 9, 2016

1. President Lazich called the regular meeting of the Lyons Public Library Board of Trustees to order at 6:05 P.M. in the Lyons Public Library Meeting Room.
2. The board started the meeting with the Pledge of Allegiance.
